Whereas, Currently, Performance Futurity nomination for the Arabian Reining Horse Class  
and the Half-Arabian/Anglo-Arabian Class is \$600 if postmarked/electronic  
transaction dated by June 1<sup>st</sup>; and  
Whereas, The Reining Horse Club has requested an increase in the nomination fee for the  
Performance Futurity Reining Horse Class(es) from \$600 to \$1000 if  
postmarked/electronic transaction dated by June 1<sup>st</sup>; Therefore, Be It  
Moved, That Article 2007.4 be revised to include: A Nomination fee of \$1000 per Reining  
Horse Class may be paid in full, postmarked/electronic transaction dated to AHA  
prior to June 1 OR  
The Nomination fee per Reining Class may be paid as follows:  
1<sup>st</sup> Payment due June 1 \$400  
After June 1, add late fee of \$25  
2<sup>nd</sup> Payment due July 1 \$300  
After July 1, add late fee of \$50  
3<sup>rd</sup> Payment due August 1 \$300  
After August 1, add late fee of \$75  
; and, Be It Further  
Moved, That Article 2007.5 be revised as follows: Nominations must be made prior to the  
original close of entries for U.S. Nationals, entries postmarked/electronic  
transaction dated after the original close of U.S. Entries must pay the total  
nomination of \$780 (\$750 nomination, \$30 office fee) plus an additional \$750 late

fee per performance class. Nominations for the Reining Horse Class must may the total nomination of \$1,030 (\$1,000 nomination, \$30 office fee) plus an additional \$1000 late fee per Reining Horse Class (to be included in the prize money pot for that particular class). Nominations are allowed with the additional \$750 late fee or the additional \$1,000 late fee for the Reining Horse Class up until the Post Entry Close date or the actual day the show office opens whichever is later and any additional U.S. National class fees (including late fees) must be paid.

**RESOLUTIONS**

**MOTION** by Dave Waggoner:

- Whereas, Resolution 16-09, Sport Horse Under Saddle Qualifications is proposing that Arabian/Half-Arabian/Anglo-Arabian horses competing at USEF/EC rated, open hunter shows be allowed to use points from placings in the under saddle phase of their working hunter division to qualify for Sport Horse Under Saddle at the Nationals and Regionals; and
- Whereas, All “other” open qualifying programs at AHA have an enrollment fee assessed;; Therefore, Be It
- Moved, That if Resolution 16-09, Sport Horse Under Saddle Qualifications is passed by the AHA Convention Delegation enrollment fees will be instituted in the amount of \$30 if done postmarked/electronic transaction dated to AHA within 30 days of the competition date; an additional fee of \$30 will apply if the show results is postmarked/electronic transaction dated after 30 days of the date of the competition; and, Be It Further
- Moved, That an additional fee of \$50 per year to have placings earned from the previous qualification year’s count toward AHA qualifications.

**SPORT HORSE NATIONAL SHOW COMMISSION**

**MOTION** by Allan Ehrlick, That AHA create an Article 1343.1.a. that reads:

“If the two-judge system (Article 1128) is utilized, each judge’s scores will be ranked and points applied according to the following system: Eleven (11) horses will be ranked based on the scores given by each judge. The following point system will be applied to determine the Top Ten, Champion and Reserve Champion:

- 1<sup>st</sup> place – 20 points
- 2<sup>nd</sup> place – 16 points
- 3<sup>rd</sup> place – 14 points
- 4<sup>th</sup> place – 12 points
- 5<sup>th</sup> place – 10 points
- 6<sup>th</sup> place – 8 points
- 7<sup>th</sup> place – 6 points
- 8<sup>th</sup> place – 5 points
- 9<sup>th</sup> place – 4 points
- 10<sup>th</sup> place – 3 points”

AHA shall also create an Article 1343.2.e. that reads: “If the two judge system (Article 1128) is used, the above point chart will be used.”

**IT PROJECT**

**MOTION** by Terry Andreasen:

Whereas, AHA has now spent 2.5 million dollars and essentially no code has been implemented into production; and

Whereas, This project is now entering its' fourth year of development; and,

Whereas, A thorough lesson learned evaluation should be a required phase of any major project; Therefore, Be It

Moved, That Glenn Petty, in conjunction with the Executive Committee, establish an IT internal audit team to audit the IT project to include but not be limited to:

1. Cost benefit analysis.
2. Project management breakdowns.
3. Current status of project.
4. Two-year projection for ongoing support for:
  - A. Hardware
  - B. Future project development costs/constraints with respect to this platform
  - C. Major project projections remaining

All of this resulting in a formalized IT long-term strategic plan.
